## AFFILIATION POLICY

### A. Definition

Affiliation with the Province of St. Mary of the Capuchin Order is a formal acknowledgment given by the Province to persons (lay, religious, clerical) who have given faithful service to a local Capuchin fraternity and/or to the Province of St. Mary. That service will be expressed by a generous giving of time, talent, or support of any kind, to foster the life and ministry of the local fraternity or the Province.

### B. Guidelines

1. Affiliation to the Province of St. Mary of the Capuchin Order can be granted only by the Provincial Minister and his Council. Recommendation for affiliation can only come from an assembled Capuchin fraternity or the Provincial Council. Whereas individual friars are free to surface a recommendation to a local chapter, it is the simple majority of the local chapter that must endorse the recommendation before forwarding it to the Provincial Council.
2. Recommendation of the affiliation shall be made through a formal letter to the Provincial Council by the local guardian. The letter shall contain reasons for the nomination together with a general biographical history of the person nominated. This request will also include a summary of the local fraternity's discussion on the nomination.
3. The person nominated should have a long-standing relationship to the local fraternity or Province, e.g. ten years or more.
4. The person nominated must have given faithful service to the local Capuchin fraternity or Province, not just to a personal ministry or friar.
5. The person should be truly virtuous, have a genuine love for the Church and for Franciscan ideals and be well thought of by the local community, both secular and ecclesial.
6. The ceremony of affiliation is to be presided over by the Provincial Minister or his delegate at a fitting ceremony.
7. A commemorative medal and a framed document of affiliation shall be given to the person and a copy of the document shall be kept in the provincial office and archives. A notice of affiliation shall be sent to all the fraternities and individual friars of the province.
8. The names of affiliates shall be listed in a special section of the *Provincial Catalogue*, listing the friaries through which they have been affiliated.
9. Our human and spiritual relationship with our affiliates is to be fostered by inviting them to local and provincial gatherings of the friars and by remembering them in our private and communal prayers. The local fraternity is to take the initiative in these matters. Local guardians are strongly encouraged to invite, at least once a year, the affiliates associated

with his fraternity to share a meal and prayer with the friars.

10. A list of benefits will be given to the one affiliated.

### **C. Benefits**

1. The primary benefit of affiliation is to share in the Masses, prayers and meritorious works of the Capuchins of the Province of St. Mary and throughout the world.
2. In order to maintain and foster this human and spiritual relationship affiliates will be invited periodically to local and/or provincial gatherings of the friars.
3. The names of affiliates shall be listed in a special section of the Provincial Catalogue, listing the friaries through which they have been affiliated. Thus their names will be associated with the friars of the Province of St. Mary of the Capuchin Order as well as with the local fraternity they have so well served.
4. Those who have been affiliated may be buried in the Capuchin habit if they so wish. In the event of serious illness or death, loved ones should contact the guardian of the local fraternity. If the deceased has expressed a desire to be buried in the Capuchin habit, a habit may be requested through the guardian who will contact the Office of the Provincial Secretary.
